
The Fastest Growing Industry Super-Sectors by County, 2022-2032


Kent County is projected to grow at an annual rate of 0.6% over the 2022-2032 projection period, which is behind Delaware's annual average growth rate of 0.7%. Over the 10-year period, the total number of net new jobs created in Kent County is projected to be 4,490. By industry, the *Financial Activities* super-sector is expected to have the fastest growth rate of 1.8% annually. *Leisure and Hospitality* and *Education and Health Services* are projected to be the second and third fastest growing super-sectors with an annual growth rate of 1.4% and 1.2%, respectively. *Information* is projected shrink at an annual rate of 4.2%.







New Castle County is projected to grow at an annual rate of 0.6% over the 2022-2032 projection period, which is behind Delaware's annual average growth rate of 0.7%. By industry, *Education and Health Services* is expected to have the fastest growth rate of 1.3% annually. *Construction* and *Manufacturing* are projected to be the second and third fastest growing super-sectors with an annual growth rate of 1.0% and 0.9%, respectively. *Information* is projected shrink at an annual rate of 2.1%.

Over the 10-year period, the total number of net new jobs created in Sussex County is projected to be 13,460. By industry, *Education and Health Services* is expected to have the fastest growth rate of 2.2% annually. *Professional and Business Services* and *Manufacturing* are projected to be the second and third fastest growing super-sectors with annual an growth rate of 2.1%. *Information* is projected shrink at an annual rate of 2.6%.
